Candidate Information:

It is the responsibility of each candidate to provide their own patient for the exam. Children are prohibited in the clinic area, and there are no facilities for childcare. Please inform your patient that children cannot be left unattended in the reception area.

Facility Fee:

The facility fee at Lamar Institute of Technology is \$100. This fee will include the use of the facility, equipment and miscellaneous supplies. The fee will be paid to CITA at the time of registration.

Personal Protection and Infection Control:

It is the policy of the Lamar Institute of Technology (LIT) Dental Hygiene Program that all personnel wear protective glasses, with side-shields, gloves and a facemask while providing treatment. This applies to dental assistants, dental hygienists and dentists. Each candidate is responsible for providing protective eye-wear with side shields.

Local anesthesia is not allowed at this exam site. Only topical anesthesia will be permitted.

Lamar Institute of Technology will provide the following equipment:

- Surface disinfectant and barriers
- Saliva ejectors, HVE suction tips
- Air and water syringe tips
- Plastic cups
- Prophy handpiece, prophy paste, disposable prophy angles, dental floss
- 2 x 2 gauze, cotton rolls
- Patient napkins
- Cotton tip applicators
- Dentsply Cavitron Select SPS Ultrasonic Scaler (uses only 30K inserts)
- Adex chairs accepts ¼ inch quick disconnections for cavitron water supply
- Dentsply Cavitron 30K black handpiece sheath for inserts
- Topical anesthetic
- Disposable tray covers
- Disposable treatment gloves and masks
- Paper gowns

Lamar Institute of Technology will not provide the following:

- -Patients for candidates
- -Protective eye-wear for the candidate and patient
- -Instruments
- -Appropriate clinic attire
- -Face shields

All instruments must be sterile, please bring them to the examination in appropriate packaging. **Sterilization services are not available prior to or after the examination.**

Radiographs:

Candidates that have not taken the required radiographs may take them on the day of the examination. There is no extra fee for taking radiographs. LIT has dental film or phosphor plates and sensors for digital x-rays. Candidates exposing radiographs on site must comply with LIT's Radiology Infection Control Procedures.
